Jim Neill: Road & Cemetery Department: (Bob Biglin represented the Road Department)

Mr. Riesterer reported that the Mills Creek Ditch has been cleaned out from Maple Avenue to Miller Road.

Mr. Riesterer informed the Board that the driveway repairs on the Eckler property on Billings Road will consist of concrete all the way to the road as opposed to the asphalt apron. Future repairs to the driveway will be the responsibility of the property owner.
