Chief Mohr gave a brief report. He said he will be ready by our next meeting to make a recommendation for a part time firefighter position.

Mr. Jim Neill gave a Road/Cemetery Report. Jim submitted his proposed road inventory and maintenance for 2015.

Jim mentioned that we need new tires for the backhoe.

Mr. Neill also asked the trustees if we may be ready to check into getting a salt building.

Mr. Neill presented new rules and regulations for the Cemetery.

The maintenance for 2015 was tabled until our next meeting.

The Trustees said we could start looking into the cost for a salt building.

The contract for the park maintenance was tabled for now.

Tire recycling will be held on June 13, 2015.

Mr. Riesterer moved, seconded by Mr. Pooch to go into executive session with the Trustees, Fiscal Officer and Chief Mohr to discuss matters confidentially permitted by law. Roll Call Vote: Mr. Riestereryes, Mr. Pooch-yes and Mr. Bias-yes.

Mr. Pooch moved, seconded by Mr. Riesterer to return to our regular meeting. Roll Call Vote: Mr. Riesterer- yes, Mr. Pooch- yes and Mr. Bias- yes.
