Mr. Riesterer moved, seconded by Mr. Pooch to accept the financial reports that were submitted by the Fiscal Officer. Vote: all ayes.

Mrs. Jane Ann Williams and ladies from the Thomas Neill Relief Corp were at the meeting. They wanted to discuss the Memorial Day Parade and Program. They hope to hold the program at the Veterans Memorial.

Mr. Pete Schade from the Health Department was at the meeting to give us an update on what they have been doing.

Fire Department had a vacation request.

Mr. Neill moved, seconded by Mr. Riesterer to grant Dan Minor his vacation request for May 3, 5 & 7 2015. Vote: all ayes.

Zoning report. The only thing was that we have had several complaints about issues at Dollar General. It was mentioned that they don't plan on putting up any signs in order to warn people of their driveway that is close to the curve.

Fiscal Officer Mary Ann mentioned that we should keep our part time employees to a max. of 25 hours per week.
